SUBJECT: Hawaii Superferry

This Procurement Circular 2007-04, Amendment 2 replaces:

Procurement Circular No. 2007-04, dated July 18, 2007; and  
Procurement Circular No. 2007-04, Amendment 1, dated July 24, 2007.

A sole source approval has been issued for the period September 1, 2007 through August 31, 2009, for executive departments. Hawaii Superferry, a new inter-island ferry service, serving the islands of Oahu, Maui and Kauai, with future service to the Island of Hawaii, is currently the single source of inter-island passenger and vehicle ferry services.

Departments and agencies may utilize Hawaii Superferry services with prior approval from the department head. The travel procedures and approval form have been amended to incorporate ferry services. Advance purchase discounts, cancellation and change fees are applicable to all reservations. Passenger and vehicle tickets are nonrefundable if cancelled within seventy-two (72) hours prior to departure.
