This suspension is in accordance with HRS §103D-702(b)(4) for deliberate failure without good cause to satisfactorily perform in accordance with terms of the contract. Therefore, bids or proposals shall not be accepted and shall not be considered for award during the suspension period pursuant to HRS chapter 103D. However, this suspension does not preclude eligibility for listing as a subcontractor on bid documents.

Pursuant to HRS §103D-702(g), prior contracts awarded to Millennium Security Inc. may remain in effect under applicable contract terms and conditions during the suspension period unless CPO makes a written determination for suspension.
