However, this suspension does not preclude eligibility for listing as a subcontractor on bid awards.

Pursuant to §103D-702(g), CPO shall make written determination on any contract awarded prior to the effective date of the suspension; consequently, contracts awarded to Millennium Security Inc. may remain in effect under applicable contract terms and conditions during the suspension period.

For Executive Departments, excluding DOE, UH, OHA and HHSC, existing contracts for Millennium Security Inc, shall remain in effect under applicable contract terms and conditions during the suspension period.
