Agenda Item I - Call to Order

Chair Greg King called the meeting to order at 1:00 p.m.

Agenda Item II - Minutes

Mr. Darryl Bardusch made a motion, seconded by Ms. Daryle Ann Ho, to approve the minutes of the April 17, 2008 meeting. The motion was unanimously carried.

Agenda Item III

Ms. Patricia Ohara, reported that she was not prepared to address this issue at this time.

Mr. Bardusch commented that the only difference between the 3 proposals is the 1st page, paragraph 2 at the bottom of proposal 1 regarding price. The board discussed the proposals and heard comments from Mr. Terry Thomason. Following the discussion, Ms. Ohara stated she would report back to the board at the next meeting.

Mr. Keith Matsumoto made a motion, seconded by Ms. Ho, to defer Agenda Item III. Mr. King, Ms. Pamela Torres, Ms. Ho, Mr. Leslie Chinen and Mr. Matsumoto voted in favor of the motion. Mr. Bardusch and Mr. Russ Saito opposed. The motion was carried.

Agenda Item IV

Mr. Bardusch stated his concern was not so much about what was being purchased, but how they were being purchased. He feels the procurement code allows for exemptions and sole source on a case by case basis.

Ms. Diane Sumida presented oral testimony on exemption no. 3. Mr. Isaac Maeda presented oral testimony on exemption no. 9. Ms. Susan Yamamoto presented oral testimony on exemption nos. 3 and 15. All of the oral testimonies were in favor of continuing the respective exemptions.

Mr. Saito made a motion, seconded by Mr. Bardusch, to defer Agenda Item IV and have SPO review their matrix for potential competition in lieu of the exemption and to add a column to summarize the written testimonies. The motion was unanimously carried.

Agenda Item V

Mr. Fujioka presented a Summary of significant legislative bills relating to procurement for 2008 and a copy of SB 2824, SD 1, HD 1, CD 1 to the board.

Mr. Fujioka stated that the next board meeting is tentatively scheduled for Thursday, June 19, 2008 at 1:00 pm.
