COOPERATIVE PURCHASING AGREEMENT**

2010 Hawaii Housing Policy Study

- I. PURPOSE of this Agreement is to provide government entities with the opportunity to participate in a multi-jurisdictional cooperative contract. It is a means by which government entities may join together in order to achieve cost-effective and efficient acquisition of quality services. Additional benefits of the cooperative procurements are the administrative and contract management savings of a single cooperative contract, rather than multiple contracts for various governmental entities.
- II. EFFECTIVE DATES OF THIS AGREEMENT shall remain in effect until the term of the contract, identified in Section V, has expired or been extended, or has been terminated for cause.
- III. SOLICITATION AND CONTRACT DEVELOPMENT/ADDITIONAL INFORMATION: The State Department of Business, Economic Development and Tourism, Hawaii Housing Finance and Development Corporation (hereinafter "DBEDT/HHFDC") is authorized to act as the procurement officer for this multi-jurisdictional cooperative solicitation, pursuant to Chapter 103D, Hawaii Revised Statutes (HRS) and Chapter 3-128, Hawaii Administrative Rules (HAR) for the following services described.




