SUBJECT: Updated State of Hawaii Purchasing Card Statewide Restricted Purchases and Blocked Merchant Category Codes

All cardholders are required to comply with the Purchasing Card Program and Procedures Manual and procurement circulars relating to the pCard Program.

For executive branch departments (excluding DOE, UH, and OHA) requests for adjustments to the MCC shall be submitted to the State Procurement Office.
