Departments currently engaged or planning to utilize the SPO Price List Contract No. 15-03 are advised to allocate sufficient time to receive and review price quotes and to issue a purchase order or execute a contract to the awarded contractor by October 31, 2017. **Purchase Orders or Contracts issued after the expiration date of October 31, 2017 are not valid.**

If the new Price List Contract No. 18-08 is not posted on the SPO website by Wednesday, November 1, 2017, participating jurisdictions shall purchase from the best available source by using the applicable procurement method and its procedures, such as small purchases or competitive sealed bidding.
