2. On Page 8, **ORDERING INSTRUCTIONS**, clause referring to the State General Excise Tax is replaced with the following:

**UNIT PRICES** include delivery to destination and all other costs except the State General Excise Tax (GET), currently 4.5% for transactions made on the islands of Oahu and Kauai,

4.25% for transactions made on the island of Hawaii, and 4% for transactions made on the islands of Maui, Molokai, and Lanai. Agencies should check with the contractors if they will be charging the new rates (for islands of Hawaii and Kauai) and agencies are advised to add the tax amount to their purchase order total.
