A request for competitive sealed proposals was issued on behalf of NASPO ValuePoint Cooperative Purchasing Organization and contracts were awarded to six (6) qualified Contractors.

The purpose of this contract is to provide electronic monitoring in the following categories: (1) Radio Frequency Monitoring ("RFM"), (2) Alcohol Monitoring ("AM"), (3) Global Positioning System Monitoring ("GPSM"), and (4) Value-Added Technology and Services.

For purchases of \$2,500 or more, agencies may use the pCard, subject to its credit limit, or issue a purchase order.

Note: Vendors may impose a transaction fee, not to exceed 4% for pCard transactions.
