The NASPO ValuePoint Purchasing Organization seeks to achieve price discounts by combining the requirements of multi-state governmental agencies, and cost-effective and efficient acquisition of quality products and services.

The State of Iowa is the current lead agency and contract administrator for the NASPO ValuePoint Tires, Tubes, and Services contract. A request for competitive sealed proposals was issued on behalf of NASPO ValuePoint Cooperative Purchasing Organization, LLC and contracts were awarded to three qualified Contractors. The State of Hawaii has signed one (1) Participating Addendum with one Contractor.

The purpose of this contract is to provide tires, tubes and related services for the following categories: pursuit and performance tires, automobile/passenger vehicles, light duty trucks, medium commercial/heavy duty trucks/buses, off-the road OTR: Radial and Bias, agriculture/farm, industrial and specialty tires.

COMPLIANCE PURSUANT TO HRS §103D-310(c). Prior to awarding this contract, the SPO verified compliance of the Contractor(s) named in the SPO Price List Contract No. 20-09. *No further compliance verification is required prior to issuing a contract, purchase order, or pCard payment when utilizing this contract.*

PURCHASING CARD (pCard). The State of Hawaii Purchasing Card (pCard) is required to be used by the Executive department/agencies, excluding the DOE, SFA, HHSC, OHA, and UH, for orders totaling less than \$2,500. For purchases of \$2,500 or more, agencies may use the pCard, subject to its credit limit, or issue a purchase order.

Note: Vendors may impose a transaction fee, not to exceed 4%, for pCard transactions.

PURCHASE ORDERS may be issued for purchases of \$2,500 or more and for vendors who either do not accept the pCard or set minimum order requirements before accepting the pCard.

SPO PL CONTRACT NO. 20-09 AND MASTER AGREEMENT NO. 19101 (The Goodyear Tire & Rubber Company) shall be typed on purchase orders issued against this price list contract. LEASE AGREEMENTS are not allowed under this contract.
