The benefits to utilize the SPO Price List contract includes:

- Efficiency savings on the procurement and contract management by SPO on behalf of all departments and agencies;
- Costs savings on the exclusion of the Federal Excise Tax for state or local government use of diesel fuel and gasoline. The cost per gallon savings for Oahu and Kauai is \$0.184 for unleaded gasoline and \$0.245 for diesel fuel; The cost per gallon savings for Maui and Hawaii is \$0.183 for unleaded gasoline and \$0.243 for diesel fuel; and
- Credit card system provides monthly reports on fuel purchases for each vehicle.

Pursuant to HRS §196-9(c) on energy efficiency and environmental standards for state facilities, motor vehicles, and transportation fuel, agencies shall use the most appropriate minimum octane fuel, provided that vehicles shall use 87-octane fuel unless the owner’s manual for the vehicle states otherwise or the engine experiences knocking or pinging.

The participating jurisdictions are **not required** but may purchase from this price list contract. Requests for an exception (form SPO-005) from the contract is not required.

Participating jurisdictions and agencies that do not utilize this price list contract may procure unleaded/diesel gasoline from other gasoline contractors with the following reminders:

- Determine that it is not advantageous or not practicable to utilize this price list contract.
- May establish an account from another gasoline contractor.
- May pay by cash and seek reimbursement accordingly.
- Are prohibited from using the State of Hawaii pCard for gasoline purchases.
- Pricing for unleaded/diesel gasoline is pump price per gallon includes the Federal Excise Tax (FET) of \$0.184 per gallon for unleaded gasoline and \$0.244 for diesel fuel. This price list contract excludes the FET; purchases from other gasoline contractors includes the FET.
- Executive Departments/Agencies (excludes DOE, OHA, UH and HHSC), pursuant to Comptroller’s Memorandum 2012-19, purchases of premium 92 grade or 89-mid-grade gasoline is prohibited unless pre-approved by the Comptroller.
- Verify contractor is compliant with all laws governing entities doing business in the State pursuant to HRS §103D-310(c):
- Participating jurisdictions are not required but may purchase from other contractors; however, HRS chapter 103D and the procurement rules apply to purchases using the applicable procurement method and its procedures, such as small purchases or competitive sealed bidding. The decision to use this contract or to solicit pricing from other sources will be at the discretion of the participating jurisdiction.

**USE OF THIS PRICE LIST CONTRACT BY NON-PROFIT ORGANIZATIONS.** Pursuant to HRS §103D-804, nonprofit organizations with current purchase of service contracts (HRS chapter 103F) have been invited to participate in the SPO price list contract.

**COMPLIANCE PURSUANT TO HRS §103D-310(c).** Prior to awarding this contract, the SPO verified compliance of the Contractor(s) named in the SPO Price List Contract No. 22-08. *No further compliance verification is required prior to issuing a contract or purchase order when utilizing this contract.*

**PURCHASING CARD (pCard).** The State of Hawaii Purchasing Card (pCard) **is not authorized** to be utilized on this price list contract.

**PURCHASE ORDERS** may be issued when utilizing this price list contract.

**SPO Price List Contract No. 22-08** will be typed on purchase orders issued against this price list contract and notated on the appropriate transaction document.

**PAYMENTS** are to be made to the remittance address of the Contractor(s). HRS §103-10 provides that the State shall have thirty (30) calendar days after receipt of invoice or satisfactory completion of the contract to make payment. The State will reject any interest payments greater than that allowed by HRS §103-10, as amended.

**COMPLIANCE PURSUANT TO HRS §103-53.** All state and county contracting officers or agents shall withhold final payment of a contract until the receipt of tax clearances from the director of taxation and the Internal Revenue Service. This section does not apply to contracts of less than \$25,000.

**VENDOR AND PRODUCT EVALUATION.** Form SPO-012, Evaluation: Vendor or Product, for the purpose of addressing concerns about this price list contract, is available to agencies at the SPO website: <http://spo.hawaii.gov>. Click on *Forms* on the home page.

**GAS CREDIT CARD** is restricted to use by authorized department or agency personnel for the purchase of gasoline and/or diesel fuel for government vehicles and motorized equipment such as lawnmowers, generators, etc.

Agencies will be issued one credit card per vehicle; however, an agency may request additional credit cards if more than one driver is assigned to a vehicle.

Within ten (10) calendar days from receipt of an application for a credit card(s), the Contractor shall issue the credit card(s) to the agency to be delivered by a carrier that ensures secured delivery of the credit card(s) to the agency within fourteen (14) business days of the effective date of the contract.

The Contractor shall include the following minimum information, screened and/or embossed on the front or back of each card issued under this contract.

1. Contractor name and logo
2. Return mailing address of Contractor
3. “*State of Hawaii*”
4. Department and Agency name

Agencies shall check their gas credit card(s) immediately to report any discrepancies to the contractor. There is a no charge to the State for the issuance of fleet gas credit cards.

**UNAUTHORIZED USE, STOLEN, OR LOST GAS CREDIT CARDS.** State agencies shall maintain a record of new and current gas credit cards issued. Unauthorized use, stolen or lost gas credit cards shall be reported to the Customer Service personnel at Aloha Petroleum Ltd or Hawaii Petroleum LLC. Customer Service name, phone number, and email for each contractor are listed herein.

**COMPTROLLER'S MEMORANDUM 2012-19**

TO: Heads of Departments

SUBJECT: Gasoline and or Diesel Fuel - Statewide

Pursuant to HRS §196-9(c) on energy efficiency and environmental standards for state facilities, motor vehicles, and transportation fuel, agencies shall use the most appropriate minimum octane fuel, provided that vehicles shall use 87-octane fuel unless the owner's manual for the vehicle states otherwise or the engine experiences knocking or pinging.

The purchase of mid 89-grade or premium 92-grade unleaded gasoline is strictly prohibited, unless justified and prior written approval of the Comptroller is obtained.

Purchases of gasoline or diesel fuel may be obtained using the State Procurement Office (SPO) price list contract for gasoline/diesel fuel and gas credit card services. Contract information is available at the SPO website: <http://hawaii.gov/spo>; click on *Price List and Vendor List Contracts* at the main menu, and *Search* for 'gasoline' and the applicable island.

**AGENCY INSTRUCTIONS TO DRIVERS OF GOVERNMENT VEHICLES.** Agencies shall provide the following information and guidelines to drivers prior to operating a vehicle:

- The gas credit card shall be used to purchase gasoline and diesel fuel for government vehicles and for motorized equipment such as lawnmowers, generators, etc. at the following designated contractors listed by island:

- Remind personnel Comptroller’s Memorandum 2012-19. The purchase of mid 89-grade or premium 92-grade unleaded gasoline is strictly prohibited unless justified and prior approval of the Comptroller is obtained.
- The gas credit card shall not be used for car washes, snacks, food items, etc.
- If personnel selects the incorrect grade of gasoline (89- or 92-grade), personnel shall immediately stop fueling and end the fuel purchase transaction. Personnel shall start again by re-swiping the gas card and selecting the correct grade of gasoline (87 grade).
- Agencies shall establish a written procedure when the last driver is responsible to top off the state vehicle gas tank when the vehicle’s gas tank reading reaches a level that warrants to be refilled.

**THE STATE GENERAL EXCISE TAX (GET) AND COUNTY SURCHARGE** shall not exceed the following rate if the contractor elects to pass the charges to its customers.

The GET or use tax and county surcharge may be added to the invoice as a separate line item and shall not exceed the current max pass-on tax rate.

County surcharges on State General Excise (GE) Tax or Use Tax may be visibly passed on but are not required. For more information on county surcharges and the max pass-on tax rate, please visit the Department of Taxation’s website at <http://tax.hawaii.gov/geninfo/countysurcharge>.

**PRICE PER GALLON** shall be the all-inclusive cost to the State except for the amount of the GET unless changed and or waived by State Federal or County laws, Hawaii Liquid Fuel Tax, County Fuel Tax, Hawaii Environmental Response Tax, Federal LUST Tax, and Federal Oil Spillage Tax. These items shall be added as separate line items when invoicing.

**FEDERAL EXCISE TAX.** The State of Hawaii is exempt from the Federal Excise Tax on gasoline and diesel fuel for Oahu, Kauai, Maui and Hawaii. The State of Hawaii shall submit the *Federal Certificate of State or Local Government Use of Diesel Fuel and Gasoline*, or as revised, to Aloha Petroleum Ltd. (Oahu and Kauai), and Hawaii Petroleum, LLC (Hawaii and Maui).

**ULSD OFF-ROAD FUEL.** The contractor is not required to offer ULSD Off-Road fuel under this contract. However, if the contractor has available for sale, ULSD Off-Road fuel at any of its gas station locations, participating agencies at its option may purchase this product using the contractor's issued fleet gas card. *ULSD Off-Road* pricing is gas pump price excluding the FET on diesel fuel.

**BIODIESEL.** The contractor is not required to offer *Biodiesel* fuel under this contract. However, if the contractor has available for sale, *Biodiesel* fuel at any of its gas station locations, participating agencies at its option may purchase this product using the contractor's issued fleet gas card. *Biodiesel* pricing is gas pump price excluding the FET on diesel fuel.

**ETHANOL FREE GASOLINE.** The contractor is not required to offer Ethanol-Free Gasoline under this contract. However, if the contractor has available for sale, Ethanol-Free Gasoline at any of its gas station locations, participating agencies at its option may purchase this product using the contractor's issued fleet gas card provided prior approval of the Comptroller is obtained as Ethanol Free gasoline is considered a higher grade of gasoline. Ethanol Free Gasoline pricing is gas pump price excluding the FET on unleaded fuel.

**ACCOUNTING.** At a minimum, the receipt shall include the following information:

- Department/Agency name and/or account number and/or identification number of individuals purchasing the gasoline.
- State vehicle license plate number or vehicle number, and/or last four numbers of the credit card number.
- Name and location of the fueling facility.
- Transaction date and time.
- Transaction or receipt number
- Quantity of gasoline in gallons
- Type of gasoline
- Unit price and extended total cost of gasoline, if available

## DEFINITIONS

- **Biodiesel** means a form of fuel derived from plants consisting of long-chain fatty acid Esters and known as B99.
- **DEF** means Diesel Exhaust Fluid.
- **Non-ethanol** means a high-quality type of gasoline that does not include added ethanol.
- **UR87** means Unleaded Regular Gasoline (87 Octane) and known as “regular”.
- **UR89** means Unleaded Regular Gasoline (89 Octane) and known as “midgrade”.
- **UP92** means Unleaded Premium Gasoline (92 Octane) and known as “premium”.
- **ULSD** means Ultra-Low Sulfur Diesel On Highway or On Road for use in on-road vehicles
- **ULSD Dyed** means Ultra-Low Sulfur Diesel Off Highway or Off Road for nonhighway use.
