SUBJECT: Summarized Updates to Procurement Code, HRS Chapters 103D and 103F for: ACT 44, SLH 2023 (HB977 HD1 SD1): SECTION 2 ACT 45, SLH 2023 (HB978 HD2 SD2 CD1): SECTIONS 2, 3 ACT 188. SLH 2023 (HB1184 HD1 SD1 CD1): SECTION 2

House Bill No. 977, HD1, SD1 was signed into law as Act 44 by the Governor on June 1, 2023, with the effective date upon its approval. ACT 44, SLH 2023, repealed the entire section of HRS §103F-202 relating to the Community Council on purchase of health and human services. Procurement Circular 2024-01 July 10, 2023 Page 2

House Bill No. 978, HD2, SD2, CD1 was signed into law as Act 45 by the Governor on June 1, 2023, with the effective date upon its approval. ACT 45, SLH 2023 amended the following HRS 103F sections:

HRS §103F-404 (a) through (e) by amending the applicability of "treatment services," the required actions for use of "treatment services," and delegates the responsibility to the head of the purchasing agency or the purchasing agency's designee.

HRS §103F-404 (f) by amending the requirement for contracts of "treatment services," in excess of \$100,000 or for a duration longer than one year, to use of an alternative applicable method of procurement pursuant to section HRS §103F-401.

HRS §103F-405 by linking the small purchases threshold of health and human services to the same threshold of small purchases pertaining to goods and services under HRS §103D-305(a).

House Bill No. 1184, HD1, SD1, CD1 was signed into law as Act 188 by the Governor on July 3, 2023, with the effective date upon its approval. ACT 188, SLH 2023 amended the following HRS 103D section:

HRS §103D-304 Procurement of Professional Services, by adding a new subsection (i), to allow agencies to rank fewer than three persons for professional services when fewer than three qualified persons respond to the solicitation, or to request to use alternative procurement procedures when no qualified person responds to the solicitation.
