SUBJECT: Hawaii Administrative Rules (HAR) Chapter 3-122,

Source Selection and Contract Formation (Interim)

The purpose of this circular is to inform all executive departments that HAR Chapter 3-122, section 3-122-1, and sections 3-122-33(b) and (d)(5), are amended, and new Subchapter 13.5, *Contractor Past Performance Database*, has been added and are in effect.

- 3-122-1 Definitions.
  - Adds the definitions for "Recent" and Relevant;" terms related to past performance in Competitive Sealed Bidding, Competitive Sealed Proposals, and Sole Source procurements.
- 3-122-33(b) Bid evaluation and award.
  - Amends the language to reflect alternative language amended in HRS 103D-302 subsection (f) that past performance, if available, shall be an added award criteria and makes other minor changes for clarification.
- Subchapter 13.5 and its section 3-122.115.01 <u>Contractor Past Performance Database</u>.
   Adds information and procedures associated with the past performance database created pursuant to Act 188, SLH 2021.
