**Declared Emergency Proclamations** 

The purpose of this circular is to 1) explain the change made to HANDS and 2) a summary of the updates.

#### **Award Postings for Governor Declared Emergency Proclamations**

Governor Declared Emergency Proclamation may include provisions to suspend Chapters 103D, and 103F, HRS, the Hawaii Public Procurement Code ("Code") and Purchases of Health and Human Services, to the extent that the compliance results in any additional delays involved in meeting

procurement requirements for selecting contractors in a timely manner to respond to emergency situations. However, this language does not suspend compliance with Chapter 103D-310(c) or award posting requirements.


To assist Departments and Jurisdictions, HANDS has been updated to include "Governor Declared Emergency Proclamation" under the "No Notice" when posting an award that did not require a solicitation notice (i.e., pre-approved sole source, pre-approved exemption, or SPO-010 over \$2,500, but less than \$15,000).

### Summary of No Notice Award Updates for Governor Declared Emergency Proclamations

At a minimum, the notice of award to the awardee shall be posted on the HANDS and the written award determination for the selected contractor and all relevant documentation shall be included in the contract file.


### "No Notice Required" Popup

Agency user logs in to HANDS to post an award notice and selects, "No Notice," will see "governor declared emergency proclamation" added to the pop-up.




#### No Notice Award - Other Method of Procurement

Agency user confirms the Category and selects "Governor Declared Emergency Proclamation" as the *Other Method of Procurement* in the dropdown menu and shall input the subject and dates for the Emergency Proclamation and relevant information.



## More Search Criteria Functionality

Agency user logs into HANDS to search for a contract award and may narrow the search by selecting "Governor Declared Emergency Proclamation" in the *Procurement Method* dropdown menu.
