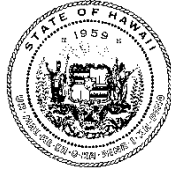

**COMPLIANCE PURSUANT TO HRS §103D-310(c).** Prior to awarding this contract, the SPO verified compliance of the Contractor(s) named in the SPO Price List Contract No. 26-03. No further compliance verification is required prior to issuing a contract or purchase order when utilizing this contract.

**PURCHASING CARD (pCard).** The State of Hawaii Purchasing Card (pCard) is not authorized to be utilized on this price list contract.

**PURCHASE ORDERS** shall be issued when utilizing this price list contract.

**SPO PRICE LIST CONTRACT NO. 26-03** shall be typed on purchase orders issued against this price list contract and notated on the appropriate transaction document.

**PAYMENTS** are to be made to the remittance address of the Contractor(s). HRS §103-10, HRS, provides that the State shall have thirty (30) calendar days after receipt of invoice or satisfactory completion of the contract to make payment.

**LEASE AGREEMENTS** are not allowed under this contract.

## CONTRACT INFORMATION

**E-10 Unleaded Gasoline in Hawaii** shall meet the specifications for automotive spark-ignition engine fuel as approved by the Measurement Standards Branch of the Hawaii State Department of Agriculture. Currently, Hawaii's gasoline must be E-10 Unleaded which is gasoline containing 10% ethanol. Ethanol, a renewable fuel, is a normal component of today's gasoline.

**Diesel in Hawaii** shall meet the specifications for automotive spark-ignition engine fuel pursuant to HRS §486-56. Ultra-Low Sulfur Diesel (On-Highway) and Ultra Low Sulfur Dyed Diesel (Off-Highway) shall meet the specifications for Diesel fuel oils pursuant to Title 4 Department of Agriculture, Subtitle 7 Divisions of Measurement Standards, Chapter 86. For more information, refer to <http://hdoa.hawaii.gov/wp-content/uploads/2012/12/AR-86.pdf>. The sale, distribution, and transportation of petroleum products specified herein shall comply with all current Federal, State, and County laws, ordinances, rules, and regulations or as revised thereafter.

**Federal Excise Tax (FET).** The State of Hawaii is exempt from the Federal Excise Tax (FET) on gasoline and diesel fuel purchased under this contract.

**Bid Base Price (BBP)** includes delivery to destination and all associated costs, excluding the taxes listed below. The Contractor shall list these taxes separately from the BBP on the invoice.

1. The GET shall be computed only on the BBP or subsequently adjusted BBP, hereinafter referred to as Adjusted Price (AP), excluding all other applicable taxes.
2. State and County fuel taxes as applicable to the appropriate County
3. Federal LUST Tax
4. Hawaii Environmental Response Tax
5. Federal Oil Spillage Tax
6. All gasoline and diesel fuel purchases from this price list contract are exempt from the FET. The FET tax shall not appear on the Agency's invoice.

**Department of Taxation Claim for the Refund of Fuel Taxes.** Each Agency (user of the fuel) has the option to apply for the Quarterly Combined Claim for Refund of Fuel Taxes Under Chapter 243, HRS and Chapter 18-243, HAR, (Form M-36), as revised, to the Department of Taxation. Form M-36 is to be filed electronically with the Department of Taxation on or before the 20<sup>th</sup> day of the month following the close of the filing period. Instructions and the form is available at the DoTAX website:

[https://tax.hawaii.gov/forms/a1\\_b3\\_5fuel/](https://tax.hawaii.gov/forms/a1_b3_5fuel/). This form is to be used for:

1. The fuel purchased was initially intended for use upon the public highways but was subsequently used off the public highways. For gasoline, the use was for operating agricultural equipment off the public highways.
  - a. Fuel taxes in excess of one cent per gallon for liquid fuels used for operating agricultural equipment in areas other than upon the public highways of the State,
  - b. Fuel taxes in excess of one cent per gallon for diesel oil used for operating motor vehicles in areas other than upon the public highways of the State, and
  - c. Fuel taxes for alternative fuel used for operating an internal combustion engine or motor vehicles in areas other than upon the public highways of the State.

## AGENCY INSTRUCTIONS

**Orders and Deliveries** of bulk gasoline, diesel, and biodiesel fuel to various State and County Agencies shall be coordinated between each Agency and the Contractor, on an as-needed basis. The Contractor shall honor all orders received during the contract period and deliver per the contract terms and within the required delivery time.

1. To schedule a delivery of bulk fuel, Agencies shall notify the Contractor with a minimum of 24 to 48 hours prior.
2. After the Contractor is notified, the Contractor shall schedule a delivery within one (1) business day, unless otherwise agreed upon.
3. Another alternative is for the Contractor to coordinate a delivery schedule with each Agency that specifies the day and time that is agreed upon by both parties.

**Failure to Deliver/Product Substitution.** Contractor shall be obliged to deliver products awarded in accordance with the terms and conditions stated herein. If the Contractor is unable to deliver products under contract, it shall be the Contractor's responsibility to obtain prior approval of the Agency to deliver an acceptable substitute at the contract price quoted. It shall be the Contractor's responsibility to obtain such substitute. In the event a Contractor consistently needs to substitute or refuse to substitute products, the SPO Procurement Officer reserves the right to terminate the contract and/or initiate the suspension/debarment process pursuant to HAR Chapter 3-126, Legal and Contractual Remedies.

**Price Adjustment.** Contractors submitted to the SPO a Base Bid Price (BBP) per gallon for each location. The BBP is subject to price adjustments, resulting in an Adjusted Price (AP) per Gallon for Agencies.

**Agency Request to Change Fuel Type or Add Fuel Tank Location.** Agencies may request a change to the fuel type being delivered or request to add fuel tank location(s), provided that the requested fuel type is listed in the Awarded Categories Chart for the Contractor and the Contractor currently supplies that fuel type on the Island. The Contractor and the State shall agree to the Bid Base Price (BBP) per gallon based on the fuel tank location and estimated gallon usage. Such changes shall be made only upon contract amendment from the SPO Procurement Officer. All terms and conditions listed in the IFB shall apply to the BBP per gallon.

To add fuel tank location(s), Agency shall email the Executive Jurisdiction POC with the following information:

1. Island, Jurisdiction, Department Name, Agency Name
2. Address of bulk tank location
3. Agency Phone Number
4. Point of Contact: Name, Phone Number, Email
5. Whether the bulk tank is above ground or below ground
6. Estimated Usage per Calendar Year (in gallons)
7. Tank size (in gallons)
8. Fuel type
9. Start date for delivery
10. Does this location have any delivery restrictions (ie. gated tank, low clearance bar, etc)

**Agency Request to Remove Fuel Tank Location.** Agencies may request to remove fuel tank location(s) listed in this contract by emailing the Executive Jurisdiction POC. Such changes shall be made only upon contract amendment from the SPO Procurement Officer.

**1,240 Gallon Temporary Tank Order Instructions.** Agencies may rent a 1,240 gallon temporary tank on wheels. Contact the designated Point of Contact at Big Island Energy Co. LLC or GP Energy Company, LLC to arrange a rental and to receive an Equipment Lease Agreement. Note: there is one tank available on Oahu and one tank available on Hawaii island (first come, first serve).
